PEACHAM POND WATER DRAWDOWN PLAN

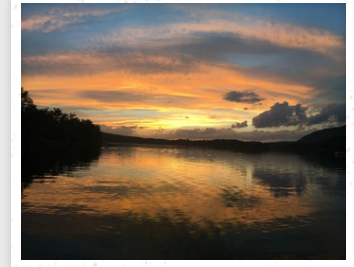
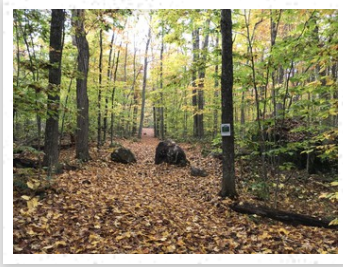
We are in the third year of the Peacham Pond Plan, implemented by the Vermont DEC and Green Mountain Power. That means for two more winters, the pond's water level will be drawn down approx. 6.6' or less. Then we will enter a five year period during which the winter drawdown will be 3.0' or less. At the end of this ten year period our pond level will not be artificially controlled unless there are special circumstances. As lakeshore property owners this will have a lot of impact on docks, decks and boathouses. Please review the attached schedule. It has been updated from the original plan.

The State of Vermont is in the process of determining whether to implement regulations on wake boats and where they can operate. During the past year the state has held public meetings, met with focus groups, received many letters and reviewed all the relevant data about wake boat use. They will continue this summer with a final group of public meetings and then make their decision whether to move forward with regulations.

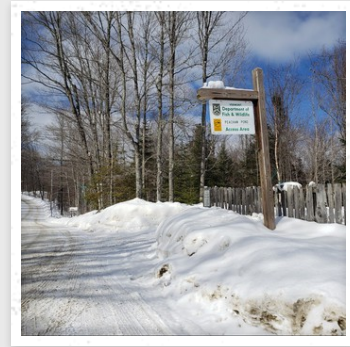
LAKE WISE

Lake Wise is a Vermont DEC program for lakeshore homeowners to learn more about lake friendly practices for their property. Last summer, Emily Finnegan (director of Caledonia County NRCD) was able to come to Peacham Pond and evaluate two properties on the east side. Mark Milazzo's property scored high enough to be granted the first Lake Wise Award on the pond. After evaluations, suggestions for improvements are made, including local resources for help. LAND TRUST TRAIL

This beautiful trail on the west side of the pond is on property owned by the Peacham Pond Land Trust. Volunteer crews have been active during both the summer and winter to make this mile plus trail more accessible. Now, thanks to Greg Vanesse, there are signs at the trail heads so everyone can see the entrance spots. Please remember this trail is open due to the kindness of the Land Trust members.



BOAT RAMP

Our public access boat ramp has some serious problems with runoff. This comes from the narrow width and steep grade of the access area. The sides of the main ramp are deep gullies, allowing a lot of sediment to enter the pond during rain events and spring runoff. Launching boats can be difficult due to the rough terrain. Emily Finnegan, the director of Caledonia County Natural Resource Conservation District recognized the problem and wrote a grant for planning some improvements. This spring she will meet with representatives of VT Fish and Wildlife, the PPA and an engineer. Proposed improvements will be shared as they are ready. If all goes well, the ramp will be improved during the summer of 2024.

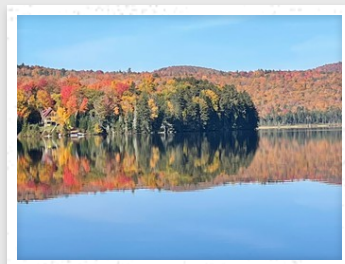
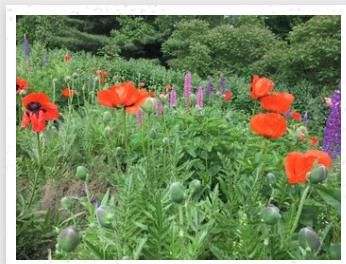
The topic is:
